Scheme: Support to Farmers for Establishment of “Silage Making Unit” under National Livestock Mission during the year 2020-21

AIM :

The aim of the scheme is to support 50 farmers for establishment of Silage Making Unit of 10 MT capacity under National Livestock Mission with a subsidy of Rs.55,250/- during the year 2020-21.

SCHEME OBJECTIVE :

- To minimize the wastage of green and dry fodder produced during flush season.
- To preserve scientifically the green fodder for the lean period & natural calamities maintaining the nutritional values and its palatability.
- To build the capacity and sensitize the farming community for preserving the surplus green fodder through ensiling in a scientific method.

ELIGIBILITY :

- All categories of farmers having at least 5 to 20 large dairy animals and cultivating fodder in their own land or in groups will be eligible to avail support.
- Preference will be given to SC/ ST/ Women farmers and entrepreneurs enlisted under various schemes namely DEDS/ CAE/ MKUY.

SOURCE OF FUNDS & CONTRIBUTION :

- Centrally Sponsored Plan Scheme.

COST OF ONE SILAGE MAKING UNIT :

FINANCAL ASSISTANCE THROUGH DBT :

- Phase-I: Rs.15,000/- as backend subsidy towards cost of civil construction of Silo unit.
- Phase-II: Rs.15,250/- as backend subsidy after stocking of the Silo pit.
- Rs.25,000/- shall be paid directly to the supplier by CDVO towards purchase and installation of motorized chaff cutter at farmers premises as per the scheme.

SUPPORT FROM THE DEPARTMENT :

- Training will be organized at Block Head Quarter level or any other convenient place after final approval of the list.
- The Silage making unit will be managed by the farmers.
- Each farmer will be trained on recommended practices of chaffing, usage of chaff cutter, packing of Silo etc.
- The concerned Livestock Inspectors, Fodder staff of the district will have to guide the farmers in field for managing the Silage units.
- The capacity building of LIs, Fodder Staff will be taken up by the DAH&VS.

DOCUMENTS REQUIRED :

- Identification Proof (Aadhaar Card).
- Land Document/ Lease Deed (Photocopy).
- Bank A/c No. with IFSCode for DBT (Photocopy).

PROCESS FOR PROVIDING SUBSIDY :

- Online application in the **ServicePlus** Portal.
- BVO checks documents, upload photo and submit verification report to CDVO.
- Approval by district CDVO and issue of Go-ahead.
- Physical verification of the Site along with inspection of civil construction of surface silo unit, Cattle & fodder availability by Block Inspection Team (BIT).
- **Release of first installment through DBT.**
- Physical verification of completion of stocking of the unit, installation of motorized chaff cutter by BVO/ SDVO/ ADVO.
- **Release of second/final installment through DBT.**
