Scheme: Support to Farmers for Crop Residue Enrichment during the year 2020-21

AIM:

The aim of the scheme is to support 1500 nos. women dairy farmers for establishment of crop residue enrichment unit with a capacity of 20 qntl. paddy straw/ crop residue for one year during 2020-21.

SCHEME OBJECTIVE:

- To feed the livestock with better nutrient enriched Crop Residue for maintaining their production as per the genetic production potentiality.
- To reduce the wastage of crop residues converting it to more palatable and digestible feed.
- To increase the farmers income by reducing the use of costly concentrate feed.
- To empower women and participation of vulnerable population.

SCHEME OUTLAY & SUBSIDY:

- The cost for establishment of one 20 qntl. Crop Residue Enrichment unit is Rs.4,400/-.
- One unit can feed 2 nos. of dairy animal for a period of 365 days.
- Back ended subsidy @ 100% through DBT mode in two phases.

ELIGIBILITY:

- All categories of women farmers.
- Farmers having at least 2 nos. of large dairy animals.
- Women farmer from all categories including SC/ ST to be included.
- MPCs/ SHG/ NMPS/ DEDS/ CAE/ Fodder Co-operative Group Women Members will be given preference.
- The beneficiaries should give willingness to contribute 20 qntl. of crop residue/ paddy straw for feeding the animals for one year.

FINANCIAL ASSISTANCE THROUGH DBT FOR ENRICHMENT OF CROP RESIDUE:

- Phase-I: Rs.2,200.00 towards completion of enrichment of 10 qntl. paddy straw/ crop residue for first six months as per specification.
- Phase-II: Rs.2,200.00 on completion of enrichment of 10 qntl. paddy straw/ crop residue for second six months of the year.

SUPPORT FROM DEPARTMENT:

- Capacity building for selected beneficiary through demonstration for establishment of Crop Residue Enrichment Unit.
- Sensitize farmer for daily enrichment of crop residue and feeding livestock as a highly nutritious feed supplement.
- The concerned Livestock Inspector/ Gomitras/ Fodder Staff will guide the farmers in field on the method(s) of enriching the Crop Residue/ Paddy Straw.

DOCUMENTS REQUIRED:

- Aadhaar Card (Photocopy) for identification purpose.
- Bank Pass Book First Page (Photocopy) Account No. with IFS Code.
- Geo-Tagged Photograph of the Crop Residue Enrichment Unit.

PROCESS FOR PROVIDING SUBSIDY:

- Online Application in **ServicePlus** Portal.
- BVO checks documents, upload photo and submit verification report to CDVO.
- Approval by CDVO with issue of Go-Ahead Letter.
- Physical verification of the women farmer premises and availability of crop residue and ingredients required for first six month by the Block Inspection Team (BVO/ VAS/ AVAS/ LI/ Fodder Officer) with Geo-Tagged Photograph.
- **Release of First Installment through DBT.**
- Procurement of inputs by the beneficiary for next six month.
- Physical verification of the unit post stocking by Block Inspection Team with Geo-Tagged Photograph.
- **Release of Second / Final Installment through DBT.**

- Status can be tracked online in the **ServicePlus** Portal.
- SMS alerts to be provided to beneficiaries.
